- C. Chief Magers informed the Board, E404 chassis and body are done and once everything passes inspection Sutphen will begin putting them together.
- D. Chief Magers informed the Board, the District is working on hiring the three approved full-time slots and would like to add a fourth since there is at least five overtime shifts per day.
