CHIEF:

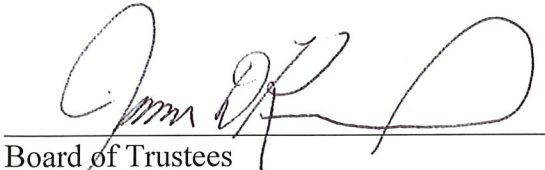
A. Chief Jack Treinish informed the Board that the District received the Ohio EMS Grant for approximately \$3,600.

- B. Chief Treinish informed the Board that the District has received the Shriner Grant for a thermal imaging camera.
 - C. Chief Treinish informed the Board, new Medic 405 is in service.
 - D. Chief Treinish informed the Board that the District is in the process of hiring ten new part-time firefighters and they are currently going through the process.
 - E. Chief Treinish informed the Board the preconstruction meeting is October 8th for the new rescue and should be completed in the Fall of 2027.
 - F. Chief Treinish presented the Board with information concerning the Stryker one year maintenance agreements for the cots and Lifepak 35's. The cost for the transport equipment ie: cots and stair chairs are \$5,576.00 and for the Lifepak 35's the cost is \$20,004.94 for a total of \$25,580.94.
- Mr. Van Buren motioned to enter into the one-year maintenance agreements with Stryker at a not to exceed cost of \$25,580.94. Ms. McKee seconded. Vote: Kincaid – yes; McKee – yes; Baker – yes; Van Buren – yes; Nauer – yes. **Motion carried.**
- G. Chief Treinish informed the Board the District is conducting farm rescue training this month.
 - H. Chief Treinish informed the Board nothing has transpired concerning the Mink St easement.
